E Mail-Bob Humphrey and Lois Humphrey Bob had back surgery and recovering. 465 people on email list.

Health Advocacy- Joe Polce

- Not a lot going on at present. A second meeting in November. Other Post Employee Benefits (OPED) shouldn't scare anyone. Board asked Insurance Council for update. Board should be putting \$30,000 annually into OPED. Retire benefits about \$14,000,000 yearly. Joe is on Sub Committee. Report includes 2 phases. Phase 1-any money the insurance fund over reserve 1/12 of total cost should be forever in reserve. Last 5 year money has been used for cost of everyone premiums. If this money is given to OPED premiums will go up. Phase 2 is extensive and confidential with public report forthcoming.
- Prescription and life insurance plans are up for renewal. All venders must be certified and qualified...there may be an increase in life insurance cost.
- Still minor problems with transfer to CareFirst especially for doctors out of network. Walkersville Eyecare biggest hold out. Saying they will give a discount.
- Insurance Council-\$3500 toward hearing aid cost must have prescription.

Legislative: Bill Price

- Question 1 on voting ballet is supplemental funding from gaming so voting important. Must totally go to access to schools, high quality for early childhood education, career tech programs, and college credits and degrees while in high school.
- There is a list of legislative MRSPA is following in pamphlet. Bill is going to workshop on Nov. 14 in Annapolis.
