

#### Medicare Changes for 2025

The standard monthly premium for Medicare Part B enrollees is \$185.00 for 2025. Medicare premiums are income-based.



The Medicare annual deductible for 2025 is now \$257, and this deductible reset on January 1, 2025. The medical deductible must be paid before medical claims are paid by CareFirst. The Delta Dental deductible also reset on January 1, 2025.

#### **Medical Plan Update**

FCPS conducted a Request for Proposal (RFP) process this fall for providing medical and vision benefits for active and retired employees. The Insurance Council and staff recommended the contract be awarded to CareFirst Blue Cross Blue Shield effective July 1, 2025. The Board of Education approved this contract at their January 22, 2025, meeting. Retirees who have medical/vision benefits with FCPS can plan to continue receiving these benefits through CareFirst Blue Cross Blue Shield.

#### FCRSPA Scholarship Program Update

In 1998, the Frederick County Retired Teachers Association started a restricted endowment fund with the Community Foundation of Frederick County to award

scholarships to deserving individuals who are pursuing a college degree in teacher education. "As retired educators, our organization knows first-hand the importance of adequately training students who will be educating our young people. It has been our long-time dream of establishing an endowed scholarship fund that will help support students with an interest who may not otherwise have the financial means to enter the teaching profession," said Jack Tritt, president of the association. The scholarship committee made up of Jack Tritt, William O. Lee, Jr., Karl Manwiller, Edith L. Wars, Richard Petre, and Phyllis Smith held a campaign entitled: "\$25,000 or more, Y2K for sure!" raising enough money to push the fund over the \$25,000 goal allowing for the first scholarship to be made in 2000-01. The first scholarship was awarded to Amy Huffer Deavers, Middletown High School graduate and now a music teacher at Green Valley Elementary. (Amy brought her chorus to one of FCRSPA's Luncheons at Morningside Inn to the delight of the attendees.)

As we celebrate the 25<sup>th</sup> Anniversary of the FCRSPA Scholarship awards, please consider making a contribution that will significantly add to the endowment fund so that the amount able to be distributed can continue to grow and the number of scholarships awarded each year can increase. As a donor advised endowment fund, gifts to the fund will never be spent; interest from the annual investment return is used to provide scholarships. FCRSPA also benefits from the FCRSPA Richard and Pat Petre Scholarship Fund which also awards scholarships to Frederick County students.

In the past several years, association members have been encouraged to contribute to the fund in March as part of the Community Service Committee's outreach. At the December 3 Holiday Breakfast FCRSPA members gathered 136 toys and \$65 in cash and checks for the Marine Corps' Toys for Tots campaign. Thanks to Sgt Ryan Campbell for his attendance and assistance in displaying and transporting all the toys, and thanks to all who contributed. Locally, the Marines have a goal of 15,000 toys; they serve about 2,500 children; they hope to give each child at least five gifts; and they do all this with only 13 staff members. It's a huge job every year.

Two large totes of donated toiletries were taken directly to SHIP (Student Homelessness Initiative Partnership). One bag of school supplies and \$5 in cash earmarked for school supplies were also donated.

The Community Services Committee continues to send our well-received "Hello" notes to Emeritus members (age 90+).

Traditionally, the March luncheon is dedicated to donations for scholarships, but feel free to bring any school supplies or toiletries you have accumulated as well to the Elks Club on Monday, March 17.

Maryland State Legislature Update

The Maryland Retired School Personnel Association's Legislative Committee, composed of members from throughout the state, is looking out for your interests in Annapolis and is your advocate. The first thing the committee does each year is review our legislative goals. Our goals this year include protecting well-earned pensions, enhancing health care, ensuring safety for seniors, supporting public education, promoting technological access for seniors, defending the right to vote, safeguarding consumer rights, helping seniors age in place, and addressing the rising cost of long-term care.

The Legislative Committee monitors bills introduced into the Maryland General Assembly and, during the legislative session, meets frequently to determine whether the Association should monitor, support, or oppose specific bills. Sometimes we write letters or testify in opposition or support of legislation and occasionally ask our members to contact their legislators in regard to a specific bill. We will keep you informed. Please contact us if you have any questions.

So far in 2025, the committee has repeated our opposition to bills that seek to restrict access to the right to vote and our support for tax credits for those that provide home care for the disabled. We will continue to have committee meetings to monitor legislative proposals.

#### FCRSPA Awards Grants to Three FCPS Teachers

Three FCPS teachers were awarded \$500 grants by the FCRSPA Board of Directors for projects designed by them to benefit students at their schools. Grants were awarded to:



#### Kate Ehrlich - Oakdale High: Black History Project - Cambridge

Ms. Ehrlich's project will focus on the Black history of Cambridge, Maryland. Students and staff will visit the area, and students will research key people and places. Using primary and secondary sources, students will become experts on one or more locations before the visit to the city and will present their findings to staff and other students. This project meets important learning goals in multiple social studies curricula, including AP US History, African American Studies, and American Studies II.

**Ryan Kint - Walkersville High**: Enhancing Engineering and Wood Design with Laser Engraving and Cutting.

Mr. Kint will use the funds towards the purchase of a laser engraving/cutting tool for use by his Project Lead The Way (PTLW) classes. PLTW is a STEM initiative class offered at most high schools. This project will serve around 150-200 students annually, supporting their design and engineering projects. Many of these students would not have access to such technology outside of the school environment, making this an essential component of their educational experience.





#### Christina Hurley - Frederick Classical Charter: Science Olympiad

Ms. Hurley's project will allow her students to compete in 23 science-based events through the Science Olympiad. These elementary students will study topics including, the anatomy of the skin, muscular and skeletal systems, earth and space science topics, amongst others. They will be required to build a Rube Goldberg machine, a tower and a helicopter. Students will also practice breaking cryptological codes. Each event requires partner teams to research the topic, learn the important material, to design models to complete tasks and to complete trial runs with their build, making changes and adaptations along the way.

#### THE GREAT FREDERICK FAIR ~ VOLUNTEERS 2024



Sixty-four volunteers of the 86 total volunteers, filled from the ranks of retired educators, served as "Ag Hosts" in the eleven agricultural themed learning centers for the 4,500 elementary-aged students and their chaperones at the Great Frederick Fair in September, some serving with friends/spouses for several days. The Frederick County Board of Education, which sanctioned Fair field trips, had reduced the number of visitation days from 4 to 3, which ran during September 16, 17, and 18, from 9:30 a.m. to 1 p.m. The Midway was closed during those mornings. Volunteers were granted free

parking and admission, as well as cold water and free ice cream for those days on which they served. There was mostly "fair weather" on those memorable days. Volunteers attended a brief in-service of duties and received their parking, admission, ice cream tickets, and day-glow vests on the Fair grounds in the City Streets and Country Roads pavilion next to Machinery Row, just off of Highland Street on the Wednesday evening before the opening of the Fair. Another retired educator, Jim Ferrant, not counted among the above 64, helped unload and reload the school children from their yellow buses. I personally thank those many, selfless volunteers.
