# President's Message by Sally Smith

I hope you are having a beautiful, although very warm, spring. I am delighted to take this chance to thank you for the opportunity to serve you as your president for the next two years and to thank Ann Miller for her dedication and leadership over the past two years.

Since joining FCRSPA several years ago I have truly enjoyed spending time with so many friends. Our association supports the Frederick community in a wide variety of initiatives, from granting scholarships, to supplying less fortunate children with needed school supplies, to maintaining our garden at the Earth and Space Lab, to donating toys to help make Christmas a little happier for children in need. I am very proud to be a member of both our local and state organization.

One of the major charges of our association is to keep members informed about issues that affect your retirement. In relation to this responsibility, many members of our Board and general membership attended the Board of Education meeting on May 27. As you may know, we all received notification concerning a change in our life insurance options, giving us the choice to maintain \$25,000 coverage at no additional cost or maintain the maximum of \$50,000 coverage at the cost of

\$24.85 a month, an increase of 400%!

Anyone opting to decrease coverage from \$50,000 to \$25,000 was to notify Human Resources by June 1. Outgoing president, Ann Miller, Joe Polce, Dan Garrett and Kyle Pritts spoke on behalf of all retirees asking the Board of Education members to change their minds on this issue. Although Board of Education members made no promise to reconsider their plan, the deadline for your response to Human Resources, Benefits Office has been extended to June 15.

The FCRSPA Annual Picnic will be held at the Jefferson Ruritan Community Center on July 14. See page 12 for details! I hope that you will be able to attend the festivities and meet this year's scholarship recipients.

# Insurance / Health Report by Joe Polce

#### LIFE INSURANCE

We had 23 retirees present at the BOE meeting on Wednesday, May 27th in an attempt to show BOE members that their decision to change the premium structure for the life insurance plan was not a positive change for the majority of retirees. Four retirees gave verbal presentations expressing disagreement with the decision. There are 320 retirees with \$25,000 or less of life insurance and 1,355 retirees with more than \$25,000 coverage. You need to know that there were five BOE members that voted for this change. You are encouraged to write or email those five with your feelings and/or concerns. It may be too late to change what has happened but if we as individuals and as an Association express our feelings and concerns, it will let the BOE members know that we are alive and active. Who knows? This factor may influence a later decision that would be in our favor. We as retirees may not have a lot of power but the one thing that we have is our VOTE.

Several members called Doris Toms and Colette Baker and ranted about this change. Some members were down-right hostile and rude. Colette presented the change to the BOE at the April 8, 2015 BOE meeting under the direction of Paula Lawton. Remember, Colette and Doris are the individuals who help us resolve problems! So, please stop yelling at the messengers and 'yell' (with your emails and letters) at the five people that actually had something to do with the fiasco. Go to <a href="https://www.fcps.org">www.fcps.org</a> and click on 'agendas and meetings' under BOE and look for the April 8, 2015 minutes and read for yourself. A decision on this was tabled until the May 6, BOE meeting, at which time it was passed.

#### **PREMIUMS FOR FY16**

This matter has not been settled as of this writing. There was information with the May 12, 2015 mailing indicating the possible premiums for FY16. Again, this has not been settled, but an increase with the medical and dental buy-up premiums will occur.

### **OPEN ENROLLMENT**

The open enrollment for Pre-Medicare and Medicare retirees will be in October. This will be your opportunity to make any changes in your health or dental plans. There may be some confusion regarding when the increase in premiums go into effect and when the open enrollment occurs. Medicare dictates that the open enrollment must occur in October. Premium increases have always been put into effect on July 1. The active employees are on a fiscal year calendar and the Medicare retirees are on a calendar year calendar. The problem became with how to mesh the two calendars without creating bigger problems. I pushed very hard to have any projected premium increase be the same for actives and retirees. After much discussion, the Insurance Council decided that the most fair way would be to begin all projected premium increases on July 1, 2015. Premiums will be in effect from July 1, 2015 until June 30, 2016. Remember, Medicare deductibles are on a calendar year, January 1 to December 31.

## SilverScript Explanation of Benefits Report

The Insurance Council met with the SilverScript representative to discuss the state of the program. It was our opportunity to discuss any problems that have occurred and to hopefully keep further problems from occurring. The following was stressed:

- Make sure that the SilverScript reps answering the phone understand the FCPS plan (EGWP + Wrap)
- Be aware that some of our retirees will be entering phase two of the plan and that FCPS retirees are exempt from that phase. (Pg. 50)
- Be aware of the specific FCPS Co-pay structure. (pgs. 54-57)

Of course, understanding the plan covers all of this.

I have stated before that when you call SilverScript, make sure that you state: I am with Frederick County Public Schools; write down the name of the rep; record the time, date and reason for the call. This will help with the resolution of a problem if the rep cannot correct the situation.

The most important part of all of this is that we be informed consumers. The handbook has very important information that we all should be reading and if not understanding, asking the appropriate questions.

## **MSRPS COLA FOR JULY 1, 2015**

The cost of living adjustment referred to as COLA will be reflected in the July check for all retirees who have been retired one full year as of July 1. For retirees who retired under the Retirement System or retired on or before July 1, 2011, the COLA will be 1.622%. For Pension System retirees who retired on or after July 2011, this year's COLA will be 1.622% on their benefit allowance based on service earned prior to July 1, 2011 and 1% on their benefit allowance based on service earned on or after July 1, 2011 since the Agency's targeted rate of investment return for December 31, 2014 was not met.

# FCRSPA: Synopsis of the Past Year by Ann Miller, Immediate Past President

Where have my two years as your president gone! I have enjoyed the time and plan to stay active in this group. However, the reins of leadership are now in Sally's capable hands.

In the last newsletter I promised to share with you the synopsis of our year's activities. This is what we have accomplished:

- At our July picnic we awarded three \$1,500 scholarships from the FCRSPA Scholarship Fund and two \$1,500 scholarships from the FCRSPA/ Richard and Pat Petre Fund to aspiring educators.
- We gathered for four additional meals through the year. At our Christmas Breakfast we collected 190 toys for the Toys for Tots program and qualified to have our logo on the Toys for Tots web site. We gave an honorary local membership to retiring FCPS Board of Education member Jean Smith. We wanted to thank her for the many years she gave supporting education in Frederick County.
- Member Carroll Kehne designed our new logo and it is a wonderful addition for our group. It has our mountains, fields, farms and spires! The FCRSPA font looks like it was written with black chalk. The logo includes our mission statement "Working Together to Protect Your Retirement." We have used our logo on our newsletter, stationery, envelopes and a banner.
- We budgeted to help maintain "our garden" at the Earth and Space Lab. (Which we established in 2013.) We also provided a donation and shopping for the FCPS Neediest Kids Fund. We continue to collect school supplies from members at our meetings. The supplies are distributed to FCPS schools.

- Members contributed more than \$2,000 at our March luncheon to increase our invested scholarship fund.

- In May we learned that the BOE had cut our life insurance coverage. Members were encouraged to contact BOE members to express the unfairness of this act toward the retirees. Four members spoke at a BOE meeting. We continue to work to get this act of discrimination against the "Old Folks" rescinded!

As you can see, we are a busy bunch of people! If you have not attended a gathering, I hope you will do so in the coming year!

It has been an honor and a great joy to have served as FCRSPA president these past two years. I believe in our organization, and I continue to be impressed in the positive contributions that we, as a united group, make to the students in Frederick County!
