Health / Insurance Report by Joe Polce

2017 Premiums

There will be **no increase** in health or dental premiums for FY18. This is due to the very healthy self-insurance fund. So, stay healthy my friends!

Plan Changes for FY18

Effective July 1, 2017 the following changes will begin:

1. Short-term outpatient physical therapy will be covered at 100% (no office co-pay). Prior authorization is required. This only pertains to active and pre-Medicare members. Medicare member's coverage remains the same.
2. Vision benefits will cover lens options for standard, deluxe, premium progressives and standard anti-reflective coating. Frames and contact lens maximums have been increased to \$150.00

A letter will be sent to all retirees in the very near future further explaining the changes.

Open Enrollment

The open enrollment for all retirees will be in October. This is when changes and/or additions can be made to the health or dental plans. Information will be mailed prior to October.

Communication to Retirees

The plan changes begin July 1, 2017 but our open enrollment is not until October. So how are retirees notified of the changes prior to October? This question is being addressed with the sending of a letter explaining the changes prior to July 1. The Insurance Council is also exploring the use of "learn-it-first" email access for retirees. This is a FCPS web site that publishes current developments f BOE and school related information. More to come later on this matter.

Consumer, Health and Fitness Tips by *Dave Markoe*

One of our members, Jim Huy, suggested my next article needs to be a little more mundane, not so much drama. I hope this edition will not be mundane, but interesting and no drama.

Recently, I was reading the [Washington Post](#) and came across an article on Brian Lowe that caught my eye. Brian developed a medical website business known as Inspire that has 1.1 million members. Membership is free and is increasing by 1,000 members each day; seventy-eight percent of the members are women.

Basically, the website provides a venue where people can enter into an online discussion about sharing experiences, information and advice about their various medical conditions. You can use your real name or an assumed name. His pitch is to “join many others who understand what you’re going through and are making important decisions about their health,” says the greeting on the Inspire web site. It appears that many people are beginning to question health care professionals by taking a more aggressive interest in their own health care. I personally think this is a good practice when there is so much health care information on the Internet and in publications. Of course, we know everything we read in the media isn’t always accurate, and this is why the Inspire website is valuable. You can enter into a dialog with people who may be having the same problems you are experiencing. These front line conversations may help you make a better decision about your health care situation.

Since 78% of the members are women, Lowe recognizes that they may be representing many family members or even a friend. Sometimes various points of view may become somewhat heated, so Inspire provides a team of moderators to make sure members get along.

You might wonder how does this venture make money. “Revenue comes from advertising and from companies looking for hard-to-find patients to participate in clinical drug trials or market research.” Many of the pharmaceutical companies will contract with Inspire to help them carry out drug trials or marketing studies. By advertising the type of clinical trials that are available, individuals can contact the pharmaceutical company to see if they may qualify as a test candidate.

Lowe states, “Inspire doesn’t advertise to promote itself. It gets exposure from many of its nonprofit organization partners, such as the American Lung Association, the National Psoriasis Foundation and the Arthritis Foundation. Some members come from posting specific medical terms on a Google search.” The article goes on to describe how these large companies desperately need subjects for their clinical trials and marketing surveys.

The idea of Inspire is “to create a safe, supportive community for patients to gather. If you are diagnosed with something serious,” he said, “we knew a community could help with those things. Patients seek other patients to get support and compare notes.”

I actually checked out the www.inspire.com website; it contains a great deal of information — check it out!

Let's Travel Together by Jim Schafer

Many of us enjoy visiting interesting places now that we have the time to travel and why not share the experiences we enjoy with other members? Welcome to this new column which gives all of us the opportunity to share the day trips, domestic travels, and international sojourns we have enjoyed. After all, "We travel not to escape life, but for life not to escape us." (author unknown). I'm not sure what is more fun: researching what I want to see or being there!

This column will be printed as often as there are submissions from you. That's all there is to it! But we must accept the fact that Linda may need to edit our submission.

For the first article, I would like to describe a trip I just completed: "Passage Through Western Europe," sponsored by Viking Ocean Cruises. This small-ship (930 passengers) line has the same high quality ship amenities as its river cruise division. I opted for a 3-day extension in Barcelona, Spain, our starting point, which was well worth it. I bought a 2-day "Hop On, Hop Off" bus pass to better understand the city which has 3 routes, each taking about 2 hours to complete, and there is narration along the way. I asked the driver if I looked like an American with my polo shirt, cargo pants, camera hanging off my neck, and wide-brimmed hat and she said "No, you need to be wearing sandals with socks." Barcelona has so much to offer: Gaudi (especially the Basilica of the Sagrada Familia and Park Guell), a little Picasso, flamenco dancers with tapas and sangria, the lovely setting of the Montserrat monastery, the Gothic Quarter, and a stroll down Las Ramblas to wonder at the old market, La Baqueria. I bought tickets to many of these attractions well in advance on www.viator.com. Once on board the Viking Star, there were 9 stops over the next 14 days in Spain, Portugal, France, England and Norway. Viking offers included excursions at each port of call which are either walking and/or bus panoramic trips. Or you may select from optional excursions and my favorites included: in the medieval town of Santiago de Compostela, walking the rooftop of the cathedral and viewing the town, then a walking tour of the town and lunch off

the square at a luxury hotel; appreciating Omaha Beach, the American Cemetery, and the museums at St. L'Eglise; eating lunch on the first level of the Eiffel Tower; and a boat ride on a Norwegian fjord during which we captured water from a waterfall which if drunk, is supposed to make one fertile (and yes I did!), and dinner at an adjacent farm with local trimmings. I asked our guide at Normandy Beach if the French youth today appreciate the sacrifice made by the allies to which she responded, "Yes. Many French children have field trips to this site to understand and appreciate the valiant efforts made by the English, Canadians and Americans to help liberate France and western Europe."

So what are you waiting for? Give all of us the opportunity to read about your day escapes, camping/RV trips, other domestic travels, and international ventures you have enjoyed.

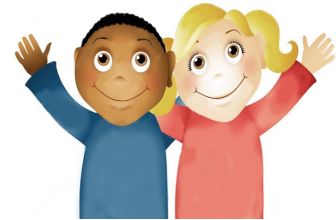
No-Sew Blanket Project for COIPP by Sally Smith
