

## Senior Tax Credit Seminar

#### Want to Save \$\$\$ on Property Taxes?

Join Diane Fox, CPA and Director of Treasury for Frederick County, on Thursday, March 10, 2016, from 1-2 PM at the Frederick Senior Center at 1440 Taney Avenue, Frederick, MD 21702 to find out if you can keep a little more of the money you pay for property taxes each year!

The program is "means tested", so assets will figure into your outcome as well as whether you qualify for the program or not. Examples used annual incomes of:

- \$44,510: reduction of \$886.49
- \$50,965: reduction of \$638.00
- \$22,944: reduction of \$1,113.62.

#### Requirements for Senor Tax Credit are:

- Homeowner must be at least 65 years of age (if multiple homeowners, then one of the homeowners applying must be 65 years of age).
- Gross income of household must be \$70,000 or less.
- All other limitations and requirements of the State Homeowner Tax Credit and County supplement apply.

#### Some of the limitations and requirements are:

- Applicant must own or have a legal interest in the property.
- Dwelling must be the principal residence of the applicant and applicant must live there at least six months of the year, including July1, unless they are a recent home purchaser or the applicant in unable to do so because of health or need for special care.
- Applicant's net worth, not including the value of the property on which the credit is being sought or any qualified retirement savings or individual retirement accounts, must be less than \$200,000.
- Credit is only granted on the taxes resulting from the first \$300,000 of assessed value of the residence.

## Insurance / Health Report by Joe Polce

#### SilverScript 2016

The new version of the SilverScript prescription plan has been mailed. I am happy to report that there are no changes the retirees have to worry about. Retirees do not have to do anything to remain registered in the plan. Please do not opt out as this will not only cancel your prescription plan, but will also cancel your medical plan. There is no return to either plans once they are cancelled. The copays are the same as in 2015. There have been changes to the formulary drug list that may cause a change from a generic copay to a preferred brand or non-preferred brand copy. There is a list of some of the changes in the 2016 Abridged Formulary Booklet that was mailed. If your specific drug is not listed, you can either call SilverScript or go online to check. The formulary list changes often which makes it difficult to follow.

#### **Preferred Pharmacies**

CVS remains as the only preferred pharmacy that will provide the best prices for 90 day prescriptions. Page 56 of the manual provides a summary of the copays for a preferred pharmacy (CVS) and all other pharmacies.

#### **Coverage Gap**

Page 51 of the new manual outlines the coverage gap scenario which is the same as the 2015 version. The bottom line is that FCPS retirees are exempt from this stage. Some retirees may reach stage two of the gap before December 31, 2015. **Do not allow a SilverScript rep to tell you that you are now in stage two and that is why your drug copay is higher.** This has happened so be aware. I am not asking for an all-out argument, but just a reminder that you know your plan better than they do. After that, just call Colette or Doris.

#### **Email Tree**

If you are not signed up to get emails from the Humphrey email tree, please do so. This is the only way to get immediate communication to retirees. Just email <u>bobandloishumphrey@verizon.net</u> and ask to be included.

## Consumer, Health and Fitness Tips by Dave Markoe

#### **Childhood Allergies**

Many of you are probably wondering why I am writing about childhood allergies since all of our kids are grown and having families of their own. Well, Linda and I are experiencing life with our first and only grandchild. So, with this in mind, I became interested, once again, in childhood illness, diseases and injuries. In some of my readings, I found several articles on childhood allergies and what we could do to help prevent many of these ailments. Maybe as a grandparent, we can pass some of this information on to our children to help our grandkids.

One big question that is popping up is whether we should expose children to germs early in life. I know when our kids were small, we tried to keep everything germ-free so the kids wouldn't get sick. But, researchers have found that children who live on farms, keep pets at home or spend time in day-care situations seem to have fewer allergies.

The other interesting point involves how we wash our dishes — either by hand or machine. One study, as reported by the Washington Post, involved 1,029 children ages 7 to 8 years old whose care provider washed dishes either by hand or with the machine. Only 12% of the families washed their dishes by hand; the others used dishwashers. The children who ate off dishes that were washed by hand were nearly half as likely to have allergies as were the children who used dishes washed in a dishwasher. The study showed that 2% of those whose dishes were hand-washed

had asthma and 23% had eczema, or allergic dermatitis, compared with 7% and 38%, of those whose dishes were machine cleaned.\*

Children may become more susceptible to allergies if they don't have contact with certain allergens, such as pet dander or dust, during the early years of life. The one article pointed out that the "hygiene hypothesis" contends that exposure to bacteria and viruses when a child's immune system is still developing makes the immune system less likely to overreact to substances that generally are not harmful.

Many of the hand-washing products such as soap, all purpose cleaners and detergents tout that they kill 99.9% of bacteria and germs. Maybe some exposure to germs will help develop a stronger immune system for all of us. I can't help but remember my mom saying playing in the dirt or getting your hands dirty once in a while isn't a bad thing. Do an inventory of your house to see how many antibacterial cleaners you are using. Maybe plain soap and water are all we need, for the most part.

## Volunteer with the Literacy Council by Dave Markoe

The Literacy Council of Frederick County (LCFC) assists adults with low-level reading skills to improve their reading and also helps recent immigrants to learn English. Tutoring is provided by trained volunteer tutors. No teaching or foreign language experience is required and all FCRSPA members would be a great fit for this volunteer opportunity. If you love to teach, this is a great way to help an individual improve his or her life. Most tutors devote between 2 and 6 hours per week to tutoring and preparation, depending on how often they meet with their student (once or twice a week) and how long each session lasts (1-1.5 hours).

Most of our adult learners refer themselves to LCFC for help, while some are referred by other organizations. Tutors and students are matched according to the times and locations they are available, and tutors can select the type of student they would like to work with (basic reading, English as a Second Language, learning or developmentally disabled, incarcerated, etc.) There are also opportunities to work with small groups such as ESL Conversation Classes and work-place literacy classes.

There are also many other non-tutoring volunteer opportunities for people who would like to help but can't commit to the regular schedule of tutoring. These include volunteering in the office or joining a committee to help with such things as outreach and communications, or fundraising. And LCFC is looking for volunteers to join our tutor training team so we can offer



training for volunteers more frequently to better keep up with the new students as they apply for tutors. Training is usually held on Saturdays several times a year, and not every trainer participates in every workshop — it is flexible. LCFC also has a current need for a volunteer tutor/student coordinator for the Basic Reading program (about 3-4 hours per week and can mostly be done from home). This is an excellent position for an experienced teacher, as the duties include advising and supporting the tutors.



#### The Great Frederick Fair 2015

Nearly fifty volunteers representing Frederick County Board of Education retired faculty and staff, the Farm Bureau, Rotary of Frederick (noon time club), and North Fork School of Equitation reported to the 153rd Great Frederick Fair over Monday, Tuesday, and Thursday (September 21, 22, and 24) to host eleven learning stations for over 4,500 students on field trips. The weather was blessedly cool and sunny throughout their Fair experience. (These trips were not part of the traditional "Fair Day" hosted this year on Wednesday, September 23, coinciding with Yom Kippur). Fair Agricultural Education committee members Jim Ferrant (chair) and John George led an orientation for volunteers on the Wednesday evening prior to this week-long event. Volunteers received chaperone guides for visiting classrooms, large Fair-themed volunteer badges (boasting wheat cluster designs), information sheets, plus parking passes and admission

tickets. Volunteers also chose their learning station: dairy, sheep/fiber station, swine, birthing center, City Streets/Country Roads, machinery row, beef, equine, Farm and Garden, poultry/rabbits, and 4-H. The "My Plate Garden" area near the popular birthing center has grown considerably since last year and may become a future station.

The Maryland Agricultural mobile unit (portable class-room), although not a station, is of great instructional value to all visitors. Children lunched in school groups after 12 noon in the grandstand. The midway is closed during the morning ... but our fifty Fair volunteers ate everywhere else throughout the busy fairgrounds and colorful midway.
