The great grandson of a slave, he graduated from college at age 19. has a M.A. degree in mathematics and received a PhDin higher education administration and statistics from the University of Illinois at Urbana-Champaign. He has been named Marylander of the Year and has received the Theodore Hesburgh Award for Leadership Excellence, the Carnegie Corporation Academic Leadership Award, the Harold McGraw Prize in Education, the Presidential U.S. Award Excellence Science. (in Mathematics. and Engineering Mentoring), the Columbia University Teachers College Medal for Distinguished Service and the Heinz Award. You do not want to miss this presentation.

FY 20 Premiums

The health insurance premiums for all members were increased by 2% effective July 1, 2019. A complete list of retiree premiums can be accessed at fcps.org. Click on Human Resources, then retiree insurance. The dental insurance premium did not increase.

COLA Adjustment for July

Eligible retirees will receive a cost-of-living adjustment in July of 2.443%.






Broadwater from the Baltimore Sun on July 5, 2019. Investment challenges have again become the issue for the managers of the retirement funds. We should be concerned.
