#### **Premiums for FY22**



A new premium rate chart was sent to all retirees that reflects a 1.25% increase in premiums effective July 1, 2021. There was also a new rate schedule for a retiree with just one dependent. This gives a retiree with just one dependent a lower premium than a retiree with two or more dependents.

#### **Open Enrollment**

An open enrollment event for retirees will take place at the Staff Development Center in Walkersville on September 24, 2021. The actual open enrollment period will be October 15-29, 2021 for benefit changes effective January 1, 2022. The open enrollment period is for retirees to make changes to the medical or dental plan. All deductibles reset on January 1, 2022.



#### **Employee Assistance Program (EAP)**

There is an Employee Assistance Program that is also available for retirees. Some of the services provided include mental health, legal advice, childcare/eldercare and financial support. The information for the dedicated phone number can be accessed at fcps.org under Human Resources. The information does not mention retirees but a retiree should just state that they are with FCPS.

#### **New Medicare Enrollees**

When a retiree turns 65 they are automatically enrolled in the Medicare program. Medicare becomes the primary insurance on the 1<sup>st</sup> of the month following the month in which they turn 65. CareFirst becomes the secondary insurance. Medicare Part A is included with the initial plan. Retirees must select Medicare Part B for which there is a premium. Failure to select Part B will result in no coverage from the secondary plan. Part B premiums are based on income and the rate schedule can be obtained at www.mymedicare.gov.

#### **CareFirst Class Action lawsuit**

(This statement is from Donna Clabaugh, Senior Manager, Benefits and Wellness)

Many of us have received a postcard from Care First/Blue Cross Blue Shield about a class action settlement. This was received because Care First was the administrator of our medical insurance plan during the dates covered by the class action suit, but you may not be entitled to any of the cash settlement. If you would like to file a claim to receive the settlement if entitled, you may do so by following the directions on the postcard. Each postcard has a unique ID number in the upper left hand corner that you will use when you file the claim. This class action settlement does not affect any benefits or our plan design. If you have questions about the settlement, please call the contact number on the post card as the FCPS Benefits team does not have additional information other than that which is on the post card.

## The Maryland State Retirement and Pension System Earns Historic 26.7% During FY 2021 Fund grows more than \$13 billion to nearly \$68 billion

Baltimore, MD (August 10, 2021) — The Board of Trustees of the Maryland State Retirement and Pension System (MSRPS) today announced that its portfolio returned a record-setting 26.7%, net of fees, on investments for the fiscal year that ended June 30, 2021. The fiscal year earnings far exceeded the System's 7.40% assumed actuarial return rate and surpassed its policy benchmark of 24.41 by 230 basis points. The fund's performance raised the System's assets to \$67.9 billion, an increase of \$13.3 billion over the prior fiscal year.

The performance of the fund over 10-year, 5-year, 3-year and 1-year periods are all above the 7.4% return assumption at 8.2%, 10.7%, 11.8% and 26.7%, respectively.

"It was an extraordinary year for the performance of System assets, the best in 35 years," said Andrew C. Palmer, Chief Investment Officer. "The attractive investment opportunities provided by the pandemic and subsequent monetary and fiscal policy responses are apparent in the rearview mirror but were not always clear in real time. Fortunately, working with the Board and the investment staff, the System was able to fully participate in the very strong returns available in most markets. Importantly, the System maintained its moderate risk posture and portfolio implementation, resulting in impressive risk-adjusted returns as well."

"The Board of Trustees has carefully designed a well-balanced portfolio of investments to meet its obligations to beneficiaries," said State Treasurer Nancy K. Kopp, Chair of the Maryland State Retirement and Pension System Board of Trustees. "The last two years have demonstrated the overall effectiveness of the Board's investment strategy, preserving value during the volatile market environment resulting from the Covid-19 pandemic and fully participating in the strong growth as economies rebounded. It's important to remember that we are long-term investors who need to balance the liquidity requirements to meet current benefit payments with the objective of generating returns for future benefit payments over an investment horizon that stretches across decades. Over the last ten years, investment returns have averaged 8.2%, exceeding the plan's expected rate of return and consistent with the Board's investment policy."
